#### Narrative

**Tickets:** Tickets are calculated at the discount rate of \$50 per ticket for musicals (22% discount); \$40 per ticket for straight plays (10% discount).

**Transportation:** Transportation will be provided for Boys & Girls Club members to attend productions for which they have tickets. PTC will charter transportation or reimburse the Boys & Girls Club for use of its buses/vans.

Artist/Educator Stipends: Artists will be compensated by the number of workshops completed, \$250 for the first workshop and \$150 per workshop thereafter up to six for each of the seven shows. Program coordinators will act as workshops assistants/facilitators up for the three hour duration of the workshop, up to six workshops for each of the seven shows. Additionally, one PTC staff member will be in attendance to act as a liason to the staff at the Boys & Girls Club.

**Production Costs:** Five percent of production costs are alloted the shows attended by the Boys & Girls Clubs.
